

Policy Statement on Pacific People and their health

As a Pacific nation, New Zealand has a responsibility to its region and to Pacific people living in New Zealand¹.

The health disparities of Pacific people in New Zealand are systemic and avoidable. There is an obligation for New Zealand to promote and protect Pacific people's health and wellbeing². Opportunities to identify the causes of health inequities within the Pacific context should be a priority for the Government.

Thus CMC will support and work where possible with:

- The Government to prioritise Pacific health in public policy and support efforts to identify and address inequities in health for Pacific peoples in New Zealand.
- HWNZ to increase support for the Pacific providers and Pacific workforce developments.
- Colleges to encourage and promote a Pacific workforce in key disciplines where there is a demand for services for Pacific people and encourage a culturally competent workforce³.
- Colleges to encourage and promote research that addresses inequity in health care in New Zealand.
- Groups working in this area to standardise approaches to collection of ethnicity data⁴.

CMC supports the work of Colleges who are undertaking health related projects in Pacific nations.

¹ Pacific peoples come from the 22 Pacific Island countries and territories and comprise distinct populations with diverse political structures, socio-economic status, language and culture. The Pacific covers some 10.6 million people living on 551,312 km² landmass spread over 165 million km² surface area of the Pacific

Ocean. Additionally, there are over 290,000 people that identify as Pacific living in New Zealand.² The primary focus of this policy is the New Zealand-based Pacific population however there are related issues that arise from the historical, familial and cultural links to the wider Pacific.
